TERM OF REFERENCES

- Report to PCU on the attendance of trainees by visiting each institute as per list of the institutes [weekly basis].
- Assessment of Training quality and learning outcomes of trainees by conducting random tests at all the institutes.
- Assessment of the competency of tutors, in context of program.
- Assessment of Training facilities [viz. Machine, Equipment, Tools, Raw material and building infra-structure required] as per base line.
- Revalidation of the curriculum [Skill and Operation] being practiced, through comparative analysis & market demands.
- Development of the forward linkages with employers and employment market for the trainees and program.
- Make a comprehensive report on outcomes of the program as defined in the RFP.

ELIGIBILITY CRITERIA

- i. The consultancy firm should have:
 - Minimum experience of 2 years in the related field.
 - Office setup / infra structure in major cities of Sindh.
 - Specialized HR / field staff to carry out the assignments.
 - NTN registration and previous audit reports.
 - Successfully completed at least two assignments in the past.
- ii. The consultancy firm should submit undertaking on affidavit to the effect that they have not been blacklisted by the Government / Autonomous bodies.
