BBSHRRDB invites sealed proposals in accordance with (**Quality and Cost Based Selection Method**) as per Rule 72 (3) of the Sindh Public Procurement Rules, 2010(amended 2013) from well reputed, competent and experienced consulting firms registered and operating under regulation of Government of Pakistan, registered with Sindh Revenue Board and income tax department (where applicable) to conduct impact assessment on the satisfaction and employability of graduates of the training program – BBSHRRDB in Province of Sindh.

Consulting firms are required to submit technical and financial proposals in two separate envelopes and be put into properly sealed & labelled single outer envelope. 2% of the bid security in the shape of Pay Order in favor of Secretary-BBSHRRDB (original must be kept with financial proposal and 01 photocopy (amount concealed) with technical Proposal). The technical proposals will be opened on same day i-e on 01 February 2018 at 1:00 pm by the Consultant Selection Committee-BBSHRRDB in presence of the consultants or their representatives. (In case of holiday or circumstances beyond control, the same schedule will be observed on next working day).

(Proposals received incomplete/conditional/ telegraphic / not on standard forms/ received after specified date and time and from black listed firms shall stand rejected)

The Procuring Agency may reject all or any proposal subject to the relevant provisions of SPP Rules 2010(amended 2013) and may cancel the bidding process at any time prior to acceptance of bid or proposal as per Rule-25 (1) of the said rules.
