



REQUEST FOR PROPOSALS FOR CONSULTANCY SERVICES- TRAINING NEEDS ASSESSMENT OF UNEMPLOYED YOUTH IN SINDH AND FUTURE CAREER NEEDS FOR TRAINING PROGRAM – BBSHRDB

Benazir Bhutto Shaheed Human Resource Research and Development Board [BBSHRDB] has been established to undertake research for development of human resource, and to provide the range of short & long-term courses/skill training, through private and public-sector training institutes contracted by Youth Development Program [BBSYDP].

BBSHRDB invites sealed proposals in accordance with (**Quality and Cost Based Selection Method**) Rule 72 (3) of the Sindh Public Procurement Rules, 2010(amended 2013) from well reputed, competent and experienced consulting firms registered and operating under regulation of Government of Pakistan, registered with Sindh Revenue Board and income tax department (where applicable) to conduct training needs assessment of unemployed youth in Sindh and future career needs for training program – BBSHRDB, in province of Sindh.

Interested consulting firms may obtain RFP document having detailed terms and conditions and eligibility criteria, from the address below w.e.f the date of publication of this notice up to Wednesday January 31,2018, on payment of document fee Rs.1000/- (Non-refundable) in the shape of Bank Draft/ Pay Order in favor of Secretary -BBSHRDB, Government of Sindh, on any working day during office hours. The firms downloading the documents from the website must submit document fee as mentioned above at the time of submission of the proposals.

Proposals complete in all respect must be submitted by 01 February 2018 till 11:00 a.m at the address given below. Consulting firms are required to submit technical and financial proposals in two separate envelopes and be put into properly sealed & labelled single outer envelope. 2% of the bid security in the shape of Pay Order in favor of Secretary-BBSHRDB (original must be kept with financial proposal and 01 photocopy (amount concealed) with technical Proposal). The technical proposals will be opened on same day i-e on 01 February 2018 at 11:30 am by the Consultant Selection Committee-BBSHRDB in presence of the consultants or their representatives. (In case of holiday or circumstances beyond control, the same schedule will be observed on next working day).

(Proposals received incomplete/conditional/ telegraphic / not on standard forms/ received after specified date and time and from black listed firms shall stand rejected)

The Procuring Agency may reject all or any proposal subject to the relevant provisions of SPP Rules 2010(amended 2013) and may cancel the bidding process at any time prior to acceptance of bid or proposal as per Rule-25 (1) of the said rules.
